



- Sedimentation
 - Reservoir >5,000 ac-ft
 - No variance required
- Evaluate individually
- Listed by reservoir or system



Agenda Item 4 Evaluation Process

Run-of-River

- Minimum annual diversion
- Sedimentation optional
 - Region H excludes
 - Conservative assumption
- Evaluate in bulk
- Listed by county and basin

Municipal Sole Source

- Minimum monthly diversion
- Evaluate individually
- Aggregated with other run-of-river







- Direct and indirect

 - Challenge to find "firm" amount
- TWDB guidance on limits
 - Expected returns based on demand
 - Permit
 - Infrastructure

Agenda Item 7 Reuse

- Interesting source to evaluate
 - Limited data
 - Challenge to ID "firm"
- Cautious approach in last RWP
 - 10-year max with recent use
- Building on method for 2021 RWP
 - Default assumption of level
 - Coordinate with WUGs on capacity
 - New reuse
 - Avoid over/under represent WMS
